Inspection of Home First Finance Company India Limited ,as per provisions of the National Housing Bank Act, 1987 – with reference to its position as on 31-03-2019: Levy of Penalty

Please refer to the show-cause notice issued to your company vide our letter no NHB (ND)/HFC/DOS/Sup./06988/2020 dated October 27, 2020, and the subsequent reply of the company.

2. The Bank has duly examined the submission of the Company and the same was found to be not acceptable by the Bank. Accordingly, NHB in exercise of the powers vested under Section 52A of National Housing Bank Act, 1987, imposes a penalty of ₹10,000/-(₹5000/- for the contravention of Paragraph 29 of the Housing Finance Companies (NHB) Directions, 2010 and ₹5000/- for the contravention of Policy Circular No 18&40) on your Company. Further, an amount of ₹1800/- towards GST @ 18% on the above penalty amount shall also be remitted by the Company. Accordingly, the Company is directed to pay the aggregate amount of ₹11, 800/- (Rupees Eleven Thousand Eight Hundred only/-) within 30 days of the date of receipt of this letter, as per the Bank details enclosed at Annexure-I.

3. The Company is advised to adhere to NHB's Policy Circular No. 93 dated February 15, 2019 with regard to the disclosure requirements of penalty imposed by the Bank. The Company is also advised to report the matter to its Board of Directors and send a copy of the minutes of the same to the Bank for information.
