The detailed instructions for the remote e-voting process and e-voting during the AGM are also provided in the Notes to the Notice of AGM.

The voting rights of Members shall be in proportion to the shares held by them in the paid-up equity share capital of the Company as on **Wednesday**, **June 18**, **2025** ("**Cut-off date**"). Those Members who will be present in the AGM through VC/OAVM facility and have not casted their vote on the Resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the AGM.

Members who would like to express their views or ask questions during the AGM may register themselves as speaker by sending their request from their registered email address mentioning their name, DP ID and client ID, No. of shares, PAN, mobile number at <u>corporate@homefirstindia.com</u> on or before 11:59 pm Wednesday, June 18, 2025.
