## POLICY ON FAMILIARIZATION PROGRAM FOR INDEPENDENT DIRECTORS

#### 1. TITLE

1.1 This policy shall be called the 'Policy on Familiarization Program for Independent Directors'.

#### 2. OBJECTIVE

2.1 The Companies Act, 2013, read with the rules thereunder, as amended (the "Companies Act") read with Regulation 25(7) of the Securities and Exchange Boardof India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI Listing Regulations") places increased responsibilities on independent directors of the Company. - 3.2 Such orientation programs / presentations / training sessions provide an opportunity to the independent directors to interact with the senior leadership team of the Companyand help them to understand the Company's strategy, business model, group structure, operations, service and product offerings, markets, organization structure, finance, human resources, technology, quality, facilities, risk management strategy, governance policies, designated channels for flow of information and such other areas as deemed necessary.
- 3.3 The programs / presentations also familiarize the independent directors with their roles, rights and responsibilities.
- 3.4 The Company may include such other details and information, as required, during the introductory familiarization program / presentation, when a new independent director comes on the board of the Company.

#### 4. REVIEW OF THE PROGRAM

**4.1** The Company may periodically review this Program and make suitable revisions, as may be deemed necessary, from time to time.

#### 5. PROGRAM AND DISCLOSURE:

- 5.1 The Program will be conducted "as needed" basis during the year.
- 5.2 As and when the Program is conducted the same will be disclosed on the website of the Company and a web link thereto shall also be given in the annual report of the Company.
